## Re: NOTICE OF DISMISSAL FRN: 0014871925 File No. ITC-214-20060404-00185

Dear Mr. Daniels:

This letter dismisses without prejudice an application filed by Teledata Solutions, Inc. d/b/a TSI (TSI) on April 24, 2006 for an International Section 214 Authorization to provide facilities-based and resale services in accordance with Sections 63.18(e)(1) and 63.18(e)(2) of the Commission's rules. We dismiss this application because of TSI's failure to pay its delinquent debts to the Commission.

Pursuant to Section 1.1910(a)(1) of the Commission's rules, the Commission examines each application to determine whether the applicant is delinquent in any non-tax debt owed to the Commission.<sup>1</sup> On April 7, 2006, the Commission notified TSI that it was delinquent on the payment of debts owed to the Commission.<sup>2</sup> The letter stated that if full payment or satisfactory arrangement to pay the delinquent debt was not made within 30 days of the date of the letter, TSI's application would be dismissed pursuant to Section 1.1910(b)(3) of the rules.<sup>3</sup> The Commission has not received payment of the debts identified in the letter, nor has TSI made other satisfactory payment arrangements with the Commission. TSI also failed to respond to a request from the FCC for financial data required for approval of a payment plan TSI had requested, and it also failed to respond to a February 5, 2007 e-mail notification that its application will be dismissed if its Commission debt is not paid.<sup>4</sup>
