Please review the following applications and advise us whether you have any national security, law enforcement, foreign policy or trade concerns by **C.O.B. **ITC-214-20061003-00449 (e-file)**

Global Telesat Corp.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a **Panama** corporation, which, is 100% owned by a citizen of the **United Kingdom**.

**ITC-214-20061004-00452 (e-file)**

T-Mobile USA, Inc.'s application for authority to provide resale services on the U.S. - Uzbekistan and U.S.-Macedonia routes. T-Mobile agrees to be classified as a **dominant** carrier on the U.S.-Macedonia route under Section 63.10 of the Commission's rules.

Deutsche Telekom AG (DT), a corporation organized under the laws of the **Federal Republic of Germany** (FRG), indirectly owns 100% of the ownership interests in T-Mobile USA, Inc. The FRG holds a 14.62% direct interest in DT. Kreditanstalt für Wiederaufbau (KfW), a bank controlled by the **German Government**, holds a 16.63% direct interest in DT. FRG holds an 80% interest in KfW.

Please note that T-Mobile related applications, **ISP-PDR-20060522-00009**, **ITC-214-20060922-00441**, and **ULS 0002618243** (Filed by VoiceStream PCS/Iowa Wireless) are being held pending your review.

If we do not hear from you by **C.O.B. October 25, 2006**, we will assume that you do not have any concerns with these applications.
