(m) For purposes of this application, Applicant submits that, with the exception of KDDI Corporation, Japan, each of these carriers qualifies for a presumption of non-dominance under Section 63.10(a)(3) of the Commission Rules, 47 C.F.R. § 63.10(a)(3), as each of these carriers lacks a 50% market share in the international transport and local access markets on the foreign end of that route. With respect to all other routes, KDDI Global L.L.C. will have no foreign carrier affiliates.

Applicant agrees to be classified as a dominant carrier on the U.S.-Japan route under Section 63.10 of the Commission's rules, without prejudice to its right to petition for reclassification at a later date."
