ITC-214-20061213-00551 (e-file)

Bridges Global Access Telecomms Limited's application for authority to provide global facilities-based and resale services between the United States and permissible international points. Two citizens of **Nigeria**, each of whom owns 60% and 20% of the applicant, respectively.

ITC-214-20061212-00552 (e-file)

ABH Communications, Corp.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Two citizens of **Dominican Republic**, each owns 33.33% of the applicant.

SCL-MOD-20061207-00012 (e-file)

Telefonica International Wholesale Services USA, Inc. and TI Wholesale Services Puerto Rico, Inc. jointly seek authority to modify their cable landing license of SAm-1 cable (SCL-LIC-20000204-00003) for an additional segment to be located between their existing cable landing station at Puerto Rico and a new destination point in Colombia. Applicants are indirectly 100% owned by Telefonica, S.A., a **Spanish** corporation, through a series of wholly-owned, intermediate subsidiaries. Telefonica is a publicly-traded company, and no person or entity owns, directly or indirectly, 10% or more of the Telefonica equity.

Affinity Mobile, LLC d/b/a Trumpet Mobile (Trumpet)'s application for authority to provide global resale services between the United States and permissible international points. Al Fawares Construction & Development K.S.C. (Al Fawares), **Kuwait** corporation, indirectly holds 65.26% ownership interest in the applicant. Three citizens of **Kuwait** have de facto control of Al Fawares.
