Dear Mr. Ball;

A. Sur Net Services, Inc. was granted International Section 214 Authority (ITC-214-20070220-00077 E) on April 24, 2007. After this grant of authority, the company changed its corporate name to Columbus Networks Services, Inc. and notified the Federal Communications Commission (the Commission) on June 8, 2007. The company once more changed its corporate name to Columbus Networks Telecommunications Services USA, Inc. (hereinafter the Grantee) as evidenced from the enclosed Articles of Amendment already filed with the Delaware Secretary of State. The Grantee continues to provide the authorized international services under the service trademark "Columbus Networks."

Although the controlling party of the Columbus Group continues to be Mr. John Risley (as originally certified in Attachment 2 of the Application for International Section 214 Authorization), the ownership structure of the Columbus Group has slightly changed after the notice provided on June 8. 2007. The non-material changes in the ownership structure of the Grantee are briefly described below and could be appreciated in the enclosed revised ownership diagram.

Glitnir hil (became Islandsbanki), which held an indirect cognizable ownership interest in the "Ultimate Parent" through Ice Can ab, transferred its interest and consequently no longer holds any direct or indirect ownership interests in the Grantee. In addition, the percentage of participation of some persons and entities holding indirect ownership interests in the Grantee has suffered minor variations. The current ownership participation is also shown in the enclosed diagram. Mr. John Risley, who had actual control over the Grantee with 47.5%

percent ownership, increased its participation to 50.5% thus he now holds a controlling and majority ownership interest.


