Notice to Surrender Certain International Section 214 Authorizations**

Dear Secretary Dortch:

By this letter, TVC Albany, Inc. d/b/a FirstLight Fiber ("TVC Albany") as successor in interest to BayRing Communications, Inc. ("BayRing"), ION HoldCo, LLC ("ION HoldCo"), National Mobile Communications Corporation ("NMCC") and Oxford Telephone and Telegraph ("Oxford") and collectively, (the "FirstLight Entities") hereby surrenders the international Section 214 authorizations ("Authorizations") that recently were assigned to TVC Albany as the result of a *pro forma* consolidation of certain of its affiliates into TVC Albany.<sup>1</sup> The following authorizations are being surrendered:

BayRing Communications, Inc. – File No. ITC-214-19961216-00630

ION HoldCo, LLC – File No. ITC-214-20070426-00164

National Mobile Communication Corporation – File No. ITC-214-20050422-00566

TVC Albany will retain and continue to provide global or limited global facilities-based and resale international telecommunications services under authorizations granted in File No. ITC-214-19900825-00538 and File No. ITC-214-20010209-00086. The surrendered Authorizations, therefore, are not needed by TVC Albany to provide international telecommunications services and surrendering the Authorizations will reduce the
