Dear Mr. Castillo Vazquez:

Attached for your response, we forward a letter submitted by the Department of Justice (DoJ), to include the Federal Bureau of Investigation, the Drug Enforcement Agency, and the U.S. Marshals Service (collectively, the "Executive Branch Agencies") requesting the Federal Communications Commission (Commission) terminate, declare null and void and no longer in effect, and/or revoke the current section 214 authorization, issued on July 27, 2007 to JuBe Communications, LLC (JuBe) under file number ITC-214-20070607-00218. The Executive Branch Agencies allege that JuBe has been wholly nonresponsive to DOJ's multiple attempts to communicate regarding the Letter of Assurance (LOA), a condition of its authorization and is therefore unable to assess JuBe's LOA compliance.<sup>2</sup>

We request that JuBe respond to the Executive Branch Agencies allegations within 30 days from the date of this letter, by **February 18, 2016**. In your response, please describe any steps that you are taking or will take with the Executive Branch Agencies to resolve their concerns. If JuBe is no longer providing services under its granted 214 authorization, and does not intend to do so in the future, please indicate whether JuBe is surrendering the authorization.

Dear Ms. Dortch:

The Department of Justice, with the concurrence of the Department of Homeland Security and the Federal Bureau of Investigation (collectively, the "Agencies"), hereby notifies the Federal Communications Commission (FCC) of the believed dissolution of JuBe Communications, LLC (JuBe) and the corresponding inability of JuBe to comply with the conditions of its international telecommunications certificate granted on July 27, 2007 (authorization file number ITC-214-20070607-00218) (DA No. 07-3505). Given such inability, the Agencies request that the FCC terminate, declare null and void and no longer in effect, and/or revoke JuBe's current authorization, file number ITC-214-20070607-00218.

Prior to JuBe receiving the above-identified certificate, the Agencies expressly conditioned their non-objection to the grant of international 214 telecommunications authorities on "the [FCC] condition[ing] its approval on the assurance of [JuBe] to abide by the commitments and undertakings set forth in its July 12, 2007 letter to Sigal P. Mandelker, Stewart A. Baker, and Elaine N. Lammert," which was attached to the Agencies' petition. (See Attachment 1 (Pet. To Adopt Cond. To Auth. and Licenses at 1 (July 26, 2007).) As stated in the public notice describing the grant of the above-referenced certificate (DA No. 07-3505), the FCC concurred with the Agencies' request and conditioned JuBe's authority to provide facilitiesbased service in accordance with Section 63.18(e)(1) of the FCC's rules, and also to provide resale service in accordance with Section 63.18(e)(2) of the FCC's rules, on JuBe "abiding by the commitments and undertakings contained in its July 12, 2007 letter to Sigal P. Mandelker, Stewart A. Baker, and Elaine N. Lammert." (See Attachment 2 at 1 (Public Notice, DA No. 07-3505) (Aug. 8, 2007).)

The Agencies have reason to believe that JuBe is no longer in existence. Specifically, according to the Texas state corporate website, JuBe was voluntarily dissolved as a corporate

entity and became inactive on October 14, 2010 (see <a href="http://www.texascorporates.com/corp/851900">http://www.texascorporates.com/corp/851900</a>). Similarly, according to the Office of the Comptroller of Texas, "the entity's franchise tax responsibilities ended because the entity has ceased to exist in its state or country of formation or has ceased doing business in Texas" (see <a href="https://mycpa.cpa.state.tx.us/coa/servlet/cpa.app.coa.CoaGetTp?Pg=tpid&Search\_Nm=jube%20">https://mycpa.cpa.state.tx.us/coa/servlet/cpa.app.coa.CoaGetTp?Pg=tpid&Search\_Nm=jube%20</a> &Buttonsearch&Search\_ID=32032246756). Further, in an October 19, 2015 e-mail message, Mr. Thomas Lynch, JuBe's designated contact during the application process, advised the Agencies that he had been unable to reach JuBe after multiple attempts through all his contacts except U.S. postal service (See Attachment 3). He noted that he presumed JuBe to be out of business but was not certain. Given all of this information, the Agencies believe that JuBe is neither providing services pursuant to authorization file number ITC-214-20070607-00218 nor still in existence.

Given the information detailed herein indicating that JuBe is no longer in existence, the Agencies respectively submit to the FCC that JuBe is unable to comply with its commitments in its July 12, 2007 letter to Sigal P. Mandelker, Stewart A. Baker, and Elaine N. Lammert and upon which the Agencies gave their non-objection to the granting of authorities and the conditions of the FCC's July 27, 2007, grant of an international telecommunications certificate. The Agencies request that the FCC terminate, declare null and void and no longer in effect, and/or revoke the international telecommunications certificate issued to JuBe, authorization file number ITC-214-20070607-00218.

### PETITION TO ADOPT CONDITIONS TO AUTHORIZATIONS AND LICENSES

The Department of Homeland Security ("DHS"), with the concurrence of the Department of Justice ("DOJ") and the Federal Bureau of Investigation ("FBI") (collectively, the "Agencies"), respectfully submit this Petition to Adopt Conditions to Authorizations and Licenses ("Petition"), pursuant to Section 1.41 of the Federal Communications Commission ("FCC" or "Commission") rules.¹ Through this Petition, the Agencies advise the Commission that they have no objection to the Commission granting its consent in the above-referenced proceeding, provided that the Commission conditions the grant on JuBe Communications, LLC ("JuBe") abiding by the commitments and undertakings contained in its July 12, 2007 letter to Sigal P. Mandelker, Stewart A. Baker, and Elaine N. Lammert (the "Letter") attached hereto as Exhibit 1.

In the above-captioned proceedings, JuBe has petitioned the Commission for an international authorization for authority to provide international facilities-based and resold services to all international points under Section 214 of the Communications Act of 1934, as amended.

As the Commission is aware, the Agencies have taken the position that their ability to satisfy their obligations to protect the national security, enforce the laws, and preserve the safety of the public could be impaired by transactions in which foreign entities will own or operate a part of the U.S. telecommunications system, or in which foreign-located facilities will be used to provide domestic telecommunications services to U.S. customers. After discussions with representatives of JuBe in connection with the proposed request, the Agencies have concluded that the commitments set forth in the Letter will help ensure that the Agencies and other entities with responsibility for enforcing the law, protecting the national security, and preserving public safety can proceed in a legal, secure, and confidential manner to satisfy these responsibilities. Accordingly, the Agencies hereby advise the Commission that they have no objection to the Commission granting the above-referenced petition provided that the Commission conditions its consent on compliance by JuBe with the commitments set forth in the Letter.

The Agencies are authorized to state that the Applicants do not object to the grant

This letter outlines the commitments made by JuBe Communications, LLC to the U.S. Department of Justice ("DOJ"), including the Federal Bureau of Investigation ("FBI"), and to the U.S. Department of Homeland Security ("DHS"), in order to address national security, law enforcement, and public safety concerns raised with regard to the JuBe Communications, LLC application to the Federal Communications Commission ("FCC") for an international authorization for authority to provide international facilities-based and resold services to all international points under Section 214 of the Communications Act of 1934, as amended.

JuBe Communications, LLC agrees that, for all JuBe Communications, LLC customer billing records, subscriber information, and any other related information used, processed, or maintained in the ordinary course of business relating to communications services offered in the United States ("U.S. Records"), JuBe Communications, LLC will make such U.S. Records available in the United States in response to lawful U.S. process. For these purposes, U.S. Records shall include information subject to disclosure to a U.S. Federal or state governmental entity under the procedures specified in Sections 2703(c) and (d) and Section 2709 of Title 18 of the United States Code. JuBe Communications,

LLC agrees to ensure that U.S. Records are not made subject to mandatory destruction under any foreign laws.

We understand that, upon execution of this letter by an authorized representative or attorney for JuBe Communications, LLC, the DOJ, FBI, and DHS shall notify the FCC that the DOJ, FBI, and DHS have no objection to the FCC's grant of the JuBe Communications, LLC application filed with the FCC.

According to the FCC's website, you are listed as the point of contact for JuBe Communications, LLC (FCC File No. ITC-214-20070607-00218). As a condition of the FCC's grant of its license, the FCC required that JuBe Communications, LLC (JuBe) comply with its July 2007 Letter of Assurances to the U.S. Department of Justice, including the Federal Bureau of investigation, and the U.S. Department of Homeland Security. Our research indicates that JuBe was dissolved in October 2010. Could you please confirm whether or not JuBe still exists as a corporate entity.
