We have received an application (File No. SCL-LIC-20070516-00008) for authority to land and operate a non-common carrier fiber-optic submarine cable system between the United States, Columbia and Jamaica (CFX-Cable System). Applicant, Columbus Networks USA, Inc. (formerly named A. Sur Net Services, Inc.) is indirectly 100% owned by Columbus International, Inc. (a **Barbadian** Corporation) which, in turn, is indirectly 47.5% owned by a **Canadian**, 37.5% owned by a **Jamaican**, and 11.87% owned by a **Icelandic** Corporation.

The above-referenced application has been filed pursuant to the provisions of the Cable Landing License Act, 47 U.S.C. §§ 34-39, section 1.767 of the Commission's rules, 47 C.F.R. § 1.767, and Executive Order No. 10530, § 5(a) (May 10, 1954), reprinted as amended in 3 U.S.C. § 301. **The applicant has certified that on May 16, 2007, it has mailed copies of the application to the Department of State, NTIA, and DOD as required by the Commission's rules 47 C.F.R. § 1.767 (j).**
