## Re: Nortel Networks Corporation, ITC-214-20070627-00248, Notification Letter

Ladies and Gentlemen:

On February 13, 2009, pursuant to 47 CFR § 63.21(i), Nortel Networks Corporation ("NNC") notified the Commission, , that its wholly-owned subsidiary, Nortel Networks, Inc. ("NNI") would undertake operations pursuant to NNC's international 214 license, granted on January 29, 2009.<sup>1</sup>

The purpose of this letter is to notify the Commission of NNI and NNC's pending bankruptcy proceedings. NNI filed for Chapter 11 bankruptcy protection on January 14, 2009.<sup>2</sup> NNI is in the process of transferring control of its wireless and other FCC authorizations to a

debtor in possession. NNI, in its current debtor in possession status, intends to continue its plan of operation pursuant to NNC's 214 authorization.

Likewise, on January 14, 2009, NNC filed for bankruptcy protection under Chapter 15 of the U.S. Bankruptcy Code.<sup>3</sup> In accordance with 47 C.F.R. § 1.65, this letter serves to notify the Commission of this change to NNC's 214 application. There has been no transfer of control as defined by the Commission's rules in connection with NNC's bankruptcy petition.
