**SUPPLEMENT TO APPLICATION FOR  
SECTION 214 AUTHORITY**

Pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 *et. al.* (1982), and 47 C.F.R §63.50 SipCom Corporation (herein called “Applicant”) file this Supplement to their application for Authority in File No.: ITC-214-20070801-00311. The above styled application was filed to the Commission by the applicant on August 01, 2007. The applicant is a reseller of Voice over Internet Protocol (VoIP) Services with other VoIP resellers in the State of Florida. The above application has been sought to expand the applicant’s services and service offerings as a small-sized business.

**BASIS FOR SUPPLEMENT**

The business proposition for the applicant seeking Section 214 Authority was to separate its services between Telecommunications and Interconnected VoIP Services under two separate entities for business and accounting purposes. On October 12, 2007, IPFast Corporation (a Florida Corporation) was incorporated to accomplish such ends pending final approval of the Applicant by the Commission to provide telecommunication services. The ownership, management, and structure of IPFast Corporation was, and continues to be, exactly the same as Applicant, SipCom Corporation, and was originally intended by ownership to be operate purely as an Interconnected VoIP Provider in the State of Florida. However, economic and other logistical hardships since filing its application on August 01, 2007 necessitated the consolidation of the two small-sized businesses into one entity. On September 26, 2008 the ownership of SIPCom Corporation and IPFast Corporation merged corporations in the State of Florida

with IPFast Corporation being the formal surviving entity. IPFast Corporation is now a reseller of Voice over Internet Protocol (VoIP) Services with other VoIP resellers in the State of Florida and its began VoIP services after the date of merger under the SipCom Corporation name.

At all times relevant the ownership, structure and management of Applicant SipCom Corporation has been exactly the same as IPFast Corporation. Post merger the Applicant has been wholly integrated into IPFast Corporation. The substance of information required by the Commission and previously submitted by SipCom Corporation as to ownership and certification, is exactly the same as IPFast Corporation, apart from Florida corporate ID Number and Federal EIN. And that, IPFast Corporation is in the process of assuming SipCom Corporation's 499 Filer ID for filing annual Telecommunications Reporting Worksheets and regulatory fee contributions.

What is sought to be supplemented herein is: (1) Application information that the Applicant has merged into IPFast Corporation since the date of its application due to economic and logistical necessities; (2) Application information that IPFast Corporation was chosen as surviving entity over SipCom Corporation in the merger based on economic and logistical necessities as a small-sized business; (3) Give notice that the ownership of IP exactly the same; and (4) Seek substitution of IPFast Corporation (formerly known as SipCom Corporation) on this application and the final grant of any authority given by the Commission under 47 U.S.C. § 214 et. al. Applicant submits that this is a minor amendment under the Commission's Rules and does not require public notice or comment.

### **CONCLUSION.**

By granting this amended application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to IPFast Corporation the surviving post merger company, under the name "**IPFast Corporation (formerly known as SipCom Corporation)**".
