Cablestar is 15.4% owned by Television International S.A. de C.V., a Mexican corporation, which is 50% owned by a citizen of Mexico, and 50% indirectly owned by Grupo Televisa S.A.B., a Mexican corporation. Further, Cablestar is 15.4% owned by Cablemas S.A. de C.V. a Mexican corporation, which is 100% owned by Alvarez Family, citizens of Mexico.
