**ITC-214-20071204-00484 (e-file)**

E&F Telecom, Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a citizen of the Republic of Korea.

**ITC-214-20071207-00494 (e-file)**

Octagon Networks, Inc.'s application for authority to provide global resale services between the United States and permissible international points. Applicant is wholly owned by a citizen of the Republic of Korea.

**ITC-214-20071211-00495 (e-file)**

Bharti Airtel Limited's application for authority to provide global facilities-based and resale services between the United States and **Singapore**. Applicant has a section 214 authorization, ITC-214-20031222-00558, to provide international services to all points except Singapore and Cuba, under the name Bharti Infotel Limited, and has changed its name to Bharti Tele Ventures Limited, effective January 19, 2006. Applicant is now known as Bharti Airtel Limited. Applicant is 45.33% owned by an Indian company and 15.58% owned by Pastel Limited, a Mauritius company. **Singapore Telecom** has a 30.45% interest in the Applicant via its 100% ownership in Pastel Limited. Therefore, applicant accepts classification as dominant carrier on the route to **Singapore**.

**Mabuhay Telecom, Inc.**'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is 50% owned by a citizen of the Philippines.
