Please review the following applications and advise us whether you have any national security, law enforcement, foreign policy or trade concerns by **C.O.B. March 12, 2008**, because we are prepared to take action on these applications. **Electronic filed (e-file) applications are able to be viewed by accessing www.fcc.gov/ibfs and searching by the file number.**

ITC-214-20080114-00012(e-file)

Tycoon Oil Company's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by Universal I.T. Inc., which is 100% owned by a citizen of **France**.

ITC-214-20080215-00061(e-file)

General Telecard LLC's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 50% owned by a citizen of the **Dominican Republic**.

ITC-214-20080221-00085(e-file)

Virtual Communications, LLC's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a citizen **Colombia**.

ISP-PDR-20080212-00003 (e-file)

Celco Partnership d/b/a Verizon Wireless (Verizon Wireless or "Petitioner") requests that the Commission extend Verizon Wireless's current authority, under Section 310(b)(4) of the Communications Act of 1934, as amended (the "Act"), to hold interests in common carrier radio licenses to encompass the licenses that are proposed to be assigned to Vista (Mirror 1) PCS License Holding, L.L.C. (Mirror 1 Sub), and to

encompass Mirror 1 Sub, which, upon consummation of the proposed transaction, will be owned 100 percent by Verizon Wireless. Verizon Wireless filed its petition for declaratory ruling in connection with an application for assignment of six broadband Personal Communications Service (PCS) licenses from Vista License Holdings, L.L.C. to Mirror 1 Sub. See File No. 0003286009.

The Petitioner states that the Commission has previously approved Verizon Wireless's foreign ownership pursuant to Section 310(b)(4), citing Applications of Vodafone AirTouch Plc and Bell Atlantic Corporation for Consent to Transfer Control or Assignment of Licenses and Authorizations, Memorandum Opinion and Order, 15 FCC Rcd 16507 (WTTB/Int'l Bur. 2000). Petitioner represents that no changes have occurred in its foreign ownership since that authorization was granted. Thus, according to Petitioner, the proposed transaction raises no new foreign ownership issues, and the Commission can and should extend the previous Section 310(b)(4) authorization to the subject PCS licenses and to Mirror 1 Sub pursuant to the rules and policies established in the Foreign Participation Order, 12 FCC Rcd 23891 (1997), Order on Reconsideration, 15 FCC Rcd 18158 (2000).

If we do not hear from you by **C.O.B. March 12, 2008**, we will assume that you do not have any concerns with the above listed applications.
