**ITNC-214-20080213-00055(e-file)**

LatinTel, Inc.'s application for authority to provide resale services between the United States and permissible international points. Applicant is indirectly 100% owned by Latinvest Investment Company II, LLC (Latinvest). Latinvest is 44.9% owned by Palladium Equity Partners III, L.P., which, in turn, is 11.8% owned by a **Spanish** corporation.

**SCL-LIC-20080213-00001(e-file)**

An application (File No. SCL-LIC-20080213-00001) for a license to land and operate in the United States a private fiber-optic submarine cable network connecting Sydney, Australia, with Piti Guam, and Madang, Papua New Guinea. One of the applicants, PPC 1 (US) Inc. is a direct, wholly-owned subsidiary of PPC 1 Limited. Another applicant, PPC 1 Limited is a direct, wholly-owned subsidiary of PIPE International Pty Ltd., an Australian proprietary company organized under the laws of Queensland, **Australia**. PIPE International is a direct, wholly-owned subsidiary of PIPE Networks Limited, an **Australian** company. PIPE Networks is 18% and 18.14%, respectively, owned by two citizens of **Australia**.

**ULS 0003189926 (e-file)**

Application filed by AWACS, Inc. (AWACS) and Puerto Rico Telephone Company, Inc. (PRTC) for consent to assign AWACS' Wireless Communications Service (WCS) spectrum holdings at 2.3 GHz in Puerto Rico and the U.S. Virgin Islands to PRTC.

PRTC elects to provide service on a non-common carrier basis with respect to the licenses that would be assigned to PRTC. Applicants state that they have consulted with the Department of Justice and Department of Homeland Security and have been authorized to inform the FCC that these agencies have no objection to the FCC's grant of this application.
