**ITC-T/C-20080206-00088(e-file)**

Applicant for consent to transfer control of section 214 authorization, ITC-214-20041201-00472, held by Symphony Telecommunications, LLC from Symphony Holdings, Inc. to Phonetime, Inc. Phonetime is located in **Ontario, Canada**, and is a provider of international and domestic long-distance services in **Canada**. Phonetime is 10% owned by Creslin, Ltd, a **Gibraltar** corporation.

**ITC-214-20080228-00090 (e-file)**

VSAT Broadband Industries Inc.'s application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a **Liberia** corporation located in **Greece**.

**ITC-214-20080303-00092(e-file)**

DISCOVERYTEL COMMUNICATIONS plc's application for authority to provide resale services between the United States and permissible international points. Applicant is incorporated in **Ireland** and is 11.2% owned by a **British Virgin Islands** corporation located in **Switzerland** which, in turn, is 100% owned by a **U.K. Corporation**.

Option Telecom Corporation's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a citizen of **Brazil**.



**ISP-PDR-20080129-00002 (e-file)**

We forwarded to you on January 31, 2008 (Ref: 2008-4) the above-referenced petition for declaratory ruling filed on behalf of Harbinger Capital Partners Master Fund I, Ltd. and Harbinger Capital Partners Special Situations Fund, L.P. (ISP-PDR-20080129-00002) (the Harbinger Funds). We did not at that time request a response by a specific date, which we are doing by this notice.

The Harbinger Funds seek permanent authority under Section 310(b)(4) of the Communications Act to acquire additional shares in SkyTerra Communications, Inc. (SkyTerra), the parent of common carrier satellite radio licensee Mobile Satellite Ventures Subsidiary, LLC (MSV), up to a non-controlling 49.99 percent equity and voting interest. As we noted in our January 31, 2008 letter, the Harbinger Funds also had filed a petition for declaratory ruling under Section 310(b)(4) requesting interim authority to purchase the additional SkyTerra shares. We transmitted that earlier-filed interim petition to you on January 14, 2008 (Ref: 2008-2) (**File No. ISP-PDR-20080111-00001**). You advised us that you had no comment on that application, provided that you were able to comment on Harbinger's interest in the context of MSV and SkyTerra's pending petition for declaratory ruling under Section 310(b)(4) (File No. ISP-PDR-20070314-00004). (The Harbinger Funds' petition for interim authority remains pending before the Commission.)

Rather than include the Harbinger interest in the MSV and SkyTerra proceeding, however, the Harbinger Funds filed the above-referenced petition for declaratory ruling to request the permanent authority Harbinger seeks under Section 310(b)(4) to acquire the additional SkyTerra shares. As a result, please advise us whether you have any national security, law enforcement, foreign policy or trade concerns with respect to the Harbinger Funds' petition for permanent authority to acquire the additional SkyTerra shares. We have placed the Harbinger Funds' petition for permanent authority on a non-streamlined public notice, released March 4, 2008. **The petition for permanent authority is attached to this letter and may also be viewed by accessing [www.fcc.gov/ibls](http://www.fcc.gov/ibls) and searching by the file number, ISP-PDR-20080129-00002.**
