May 28, 2008**, because we are prepared to take action on these applications. **Electronic filed (e-file) applications are able to be viewed by accessing www.fcc.gov/ibfs and searching by the file number.**

ITC-214-20080508-00208 (e-file)

Phone to **Korea's** application for authority to provide resale services between the United States and permissible international points. Applicant is 100% owned by a citizen of **South Korea**.

ITC-214-20080506-00211 (e-file)

Virtual Voice Versatility, LLC's application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is 66.6% owned by a citizen of **Israel**.

ISP-PDR-20080501-00011 (e-file)

SES-T/C-20080307-00254 & 00255

Vizada, Inc requests a declaratory ruling that its indirect foreign ownership in excess of the 25 percent benchmark in section 310(b)(4) of the Communications Act by the foreign entities identified in its petition is in the public interest. Vizada, Inc. seeks approval of the same ownership foreign ownership interests as its affiliate Vizada Services, LLC is requesting in **ISP-PDR-20060804-00010**, which remains pending at the Commission and under review by the Executive Branch agencies. Vizada, Inc. and Vizada Services LLC are under 100% common ownership and control.

The Commission previously issued a foreign ownership ruling to Vizada, Inc. in a 2007 decision approving the transfer of control of Vizada, Inc. (formerly, Telenor Satellite

Inc.) to MobSat Holding Norway AS (formerly, Inceptum 1 AS). See Telenor ASA, Transferor, and Inceptum 1 AS, Transferee, Seek FCC Consent to Transfer Control of Licenses and Authorizations and a Declaratory Ruling on Foreign Ownership, Public Notice, IB Docket No. 06-225, DA 07-2163, 22 FCC Rcd 9325 (2007) (2007 Ruling). Vizada now requests approval for additional foreign equity and voting interests, primarily interests held by and through MobSat Management Sarl, a newly formed Luxembourg limited liability company through which certain individuals involved in management have been allowed to acquire shares.

In addition, Vizada, Inc. seeks approval for a proposed pro forma restructuring under which **Norwegian-organized** Vizada AS (formerly, Telenor Satellite Services AS), would be inserted into Vizada Inc.'s ownership chain. The companion *pro forma* transfer applications have been assigned File Nos. **SES-T/C-20080307-00254** and **SES-T/C-20080307-00255**.

If we do not hear from you by **C.O.B. May 28, 2008**, we will assume that you do not have any concerns with the above listed applications.
