Global Telecom & Technology Americas, Inc. ("GTT Americas"), by its counsel and pursuant to Section 63.21(h) of the Commission's Rules, hereby notifies the Commission that its direct, wholly owned subsidiary, WBS Connect, L.L.C. ("WBS"), a Colorado limited liability company, will be providing service under GTT Americas' international Section 214 authorization, **ITC-214-20020619-00332**. Effective December 11, 2009, the Commission approved the transfer of ultimate control of WBS to GTT Americas' parent, Global Telecom & Technology, Inc. ("GTT"), in WC Docket No. 09-202. GTT Americas is a direct, wholly owned subsidiary of GTT and, in turn, WBS is a direct, wholly owned subsidiary of GTT Americas. Because GTT Americas holds the 214 license referenced above, WBS's license is duplicative and no longer needed. Thus, WBS hereby surrenders its 214 license, **ITC-214-20080904-00419**, and notifies the Commission that it will operate pursuant to **ITC-214-20020619-00332**, the 214 license of its parent, GTT Americas.
