
Re: Mox Telecom AG; Section 214 Authorization

Dear Secretary Dortch:

On January 28, 2009, Mox Telecom AG (“Mox AG”) notified the Federal Communications Commission, pursuant to 47 C.F.R. § 63.21(h), that its wholly-owned subsidiary, Mox Telecom Ireland Ltd. (“Mox Ireland”), commenced providing service under authority of the international section 214 authorization held by Mox AG.<sup>1</sup> Mox AG, by its undersigned attorney, hereby notifies the Commission that Mox Ireland no longer services any customers in the U.S., will no longer provide international telecommunications services in the U.S., and will no longer need to operate under the international section 214 authorization of its parent company.
