
Dear Mr. Nasir:

Our records indicate that your international 214 application (File No. ITC-214-20090505-00197) remains pending at the Commission awaiting completion of the Executive Branch agencies review. We forwarded the application to Executive Branch agencies on August 19, 2005. You should have been contacted by the Executive Branch agencies requesting information about your application for purposes of their review.

On March 4, 2010, the Executive Branch agencies informed the Commission that on October 16, 2009, they were notified by your counsel that you became a United States citizen on September 25, 2009. You are required to keep current relevant information in your application. In addition, as the sole owner of Sarah Telecom LLC, U.S. citizenship would remove foreign ownership issues related to this application necessitating coordination of the application with the Executive Branch agencies.
