Corporate Stockholders, Officers and Directors

Telaurus Communications LLC is a wholly owned subsidiary of Globecomm Systems, Inc. ("GSI"). GSI is a Delaware corporation which is publicly traded. As has been previously disclosed, there is no particular individual or entity which owns or votes more than 20% of the capital stock of GSI. Despite previous information to the contrary, upon further research, it has also been established that there are no owners which own or vote more than 10% of the capital stock of GSI. GSI has previously listed Brown Advisory Securities, LLC ("Brown Advisory") as an "owner" but in fact that entity does not own any GSI stock. Rather Brown Advisory counsels individual clients who are both the owners and hold the voting rights for the stock. There are no stock holders who own or votes more than 10% of GSI stock. Accordingly Brown Advisory does not have any equitable or beneficial ownership of GSI stock and is not an owner for purposes of this response.
