Re: Notice of Discontinuance of Service Pursuant to 47 C.F.R. § 63.19

Dear Ms. Dortch:

Pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.19 of the Commission's rules, 47 C.F.R. § 63.19, GTI Corporation d/b/a GTI Telecom ("GTI") hereby notifies the Commission that it plans to discontinue its provision of Call-on-Demand, an application of an international long-distance calling service, effective December 31, 2015. Call-on-Demand allows subscribers to pay seven cents per minute for calls made without purchasing a physical calling card. GTI's discontinuance of the Call-on-Demand service application will affect customers located in all 50 U.S. States. However, GTI will offer a substitute international calling application to these customers.

GTI provides international service pursuant to International 214 Authorization Number ITC-214-20090831-00403.¹ GTI has provided written notification to all affected customers at least 30 days prior to the planned discontinuance, a copy of which is attached hereto.
