


**Attachment A**

**CERTIFICATE**

The undersigned hereby certifies, on behalf of Vodacode, LLC ("Vodacode" or "Applicant") with respect to the foregoing application for authority to provide international services, that:

3. Vodacode does not seek to provide international telecommunications service to any destination where: (1) Vodacode is a foreign carrier in that country; (2) Vodacode controls a foreign carrier in that country; (3) any entity that owns more than a 25% interest in Vodacode, or controls Vodacode, controls a foreign carrier in that country; or (4) two or more parties own, in the aggregate, more than 25% of Vodacode and are parties to, or the beneficiaries of, a contractual relationship that affects that provision or marketing of international basic telecommunications services in the United States.
4. Vodacode has not agreed to accept special concessions directly or indirectly from any foreign carrier with respect to any U.S. international route where the foreign carrier possesses sufficient market power on the foreign end of the route to affect competition adversely in the U.S. market and will not enter into such agreements in the future.
5. No party to this application is subject to a denial for Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. 853 (a).

## **Attachment B**

Vodacode, LLC (“Vodacode” or “Applicant”) provides the following information required by 47 CFR §63.18 with respect to its Application for Authority to provide international telecommunications services:

- (d) Vodacode has not previously received Section 214 authority from the Commission.

Vodacode requests authority to serve all countries permitted under a grant of global authority.
