Supplemental Information of APCC Services


APCC Services, Inc. hereby files this Supplemental Information of APCC Services in the above referenced matter. This Supplemental Information of APCC Services, Inc. updates the Commission with regard to developments since APCC Services submitted the Further Supplemental Comments of APCC Services, Inc. on April 5, 2010 (*APCC Further Supp.*), the Supplemental Comments of APCC Services, Inc on January 20, 2010 (*APCC Supp.*), and the Reply Comments of APCC Services, Inc, on December 28, 2009 ("*APCC Reply*"). In this Supplemental Information, APCC Services brings to the attention of the Commission developments since filing of the April 5 *APCC Further Supp.*

APCC Services had no contact or other communication with Next-G since filing of the *APCC Reply* in December until very recently. In the last few weeks, Next-G has sent some compensation and Completing Carrier reports to APCC Services, as follows:

Although all of these payments are late in varying degrees¹, interest was paid on none, and all reflect payment on a per cent of completed calls (relative to the number of calls reported by Intermediate Carriers as sent to Next-G, see the column entitled “% of Pmt to Reported IC Calls”) totally at odds with the per cent of calls on which other switch based resellers like Next-G pay and are even at odds with Next-G’s own historical percentages of completed calls, APCC Services believes that the fact of the payments makes it worthwhile to engage in discussions with Next-G to address Next-G’s willingness to bring it into compliance with the Commission’s rules, and APCC Services intends to initiate those discussions forthwith.

3. I have explained in my previous declarations in this proceeding my qualifications, experience and competence to make a declaration asserting facts in connection with the relations between APCC Services and Next-G.

4. Recently APCC Services has received payments from Next-G as follows:



The first column, "I/C Year/Qtr", tells the quarter for which the payment was received, the second column, "IC reported Calls", tells the number of calls Intermediate Carriers reported sending to Next-G during the quarter, the third column, "Actual Pmt Recv'd", tells the amount of the payment received for the relevant quarter, the fourth column, "% of Pmt to Reported IC Calls", tells for the relevant quarter the ratio of calls paid by Next-G to the calls reported as sent by Intermediate Carriers to Next-G expressed as a percentage, the fifth column, "Pmt Due Date", tells when the payment was due for the relevant quarter, the sixth column, "Pmt Received Date", tells the date when the payment for the relevant quarter and the Completing Carrier report was received, and the last column, "Interest Pd." tells the amount of interest paid on the late payment for the relevant quarter.

Although all of these payments are late in varying degrees, interest was paid on none, and all reflect payment on a per cent of completed calls relative to the number of calls reported by Intermediate Carriers as sent to Next-G, totally at odds with the per cent of calls on which other switch based resellers like Next-G pay and even with Next-G's own percentages of completed calls, APCC Services believes that the fact of the payments makes it worthwhile to engage in discussions with Next-G to address Next-G's willingness to bring it into compliance with the Commission's rules, and APCC Services intends to initiate those discussions forthwith.


