APPLICATION

3G Collect, LLC. (“3G COLLECT” or “Applicant”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982), and Section 63.18 of the Federal Communications Commission's (“Commission”) Rules, 47 C.F.R. § 63.18, to provide global or limited resale authority between the United States and international points, except those international points not authorized by the Commission (the “Application”). 3G COLLECT is a U.S. company organized to provide international telecommunications services. 3G COLLECT serves business customers throughout the United States. By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to 3G COLLECT.

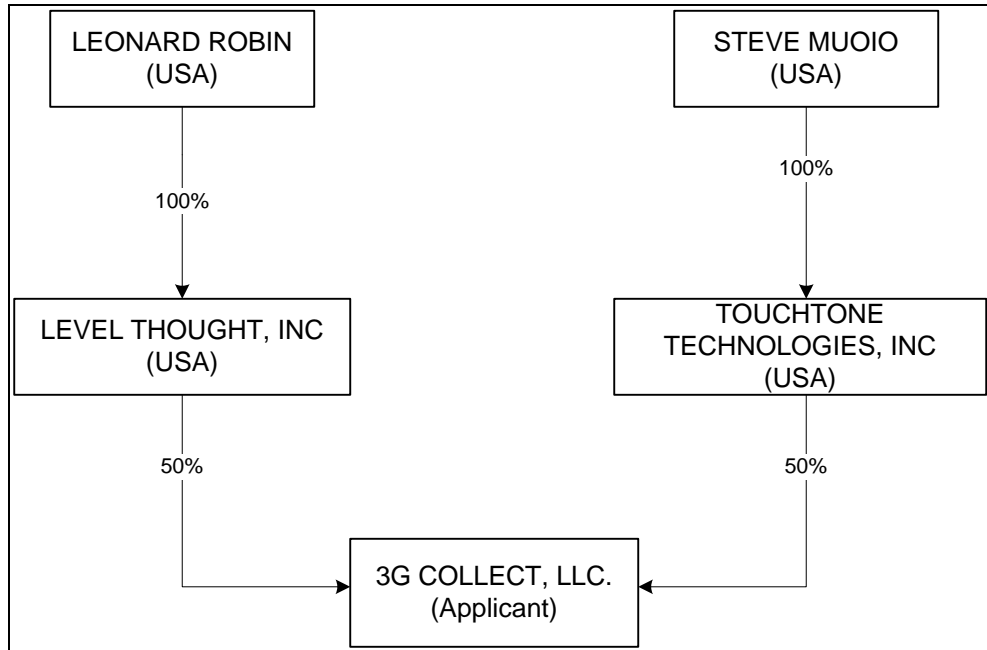


Figure 1. Ownership structure of Applicant

- (i) 3G COLLECT is affiliated with the following US carriers: Verizon, XO Communications. 3G COLLECT is affiliated with the following foreign carriers: Telmex (Mexico) and Telenor (Norway). However, 3G COLLECT does not wish to serve markets in Mexico or Norway. 3G COLLECT does not terminate calls from the USA to Mexico or from the USA to Norway. 3G COLLECT receives calls originating on these foreign carriers and terminates the calls to US cell phones.
- (j) 3G COLLECT certifies that it does not seek to provide international telecommunications services to any destination country for which any of the following is true:

1. 3G COLLECT is a foreign carrier in that country; or
2. 3G COLLECT controls a foreign carrier in that country; or
3. Any entity that owns more than 25 percent of 3G COLLECT, or that controls 3G COLLECT, controls a foreign carrier in that country.

(n) 3G COLLECT certifies that it has not agreed to accept special concessions directly or indirectly from any foreign carrier with respect to any U.S. international route where the foreign carrier possesses market power on the foreign end of the route and will not enter into such agreements in the future.

(o) 3G COLLECT certifies that pursuant to Sections 1.2001 through 1.2003 of the Commission's Rules, no party to this Application has been denied federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988.

(p) 3G COLLECT requests streamline processing pursuant to Section 63.12 of the Commission's Rules. 3G COLLECT certifies that:

1. It is not affiliated with a foreign carrier in a destination market it seeks authority to serve;
2. It has no affiliation with a dominant U.S. carrier whose international switched or private line services 3G COLLECT seeks authority to resell either directly or indirectly through the resale of another reseller's services;
3. It does not seek authority to provide switched basic services over private lines to a country for which the Commission has not previously authorized the provision of switched services over private lines; and
4. The Commission has not informed 3G COLLECT in writing that this Application is not eligible for streamline processing.

In conclusion, 3G COLLECT certifies that all of the information in this Application is accurate and correct. For these reasons, 3G COLLECT respectfully requests that the Commission grant this Application.
