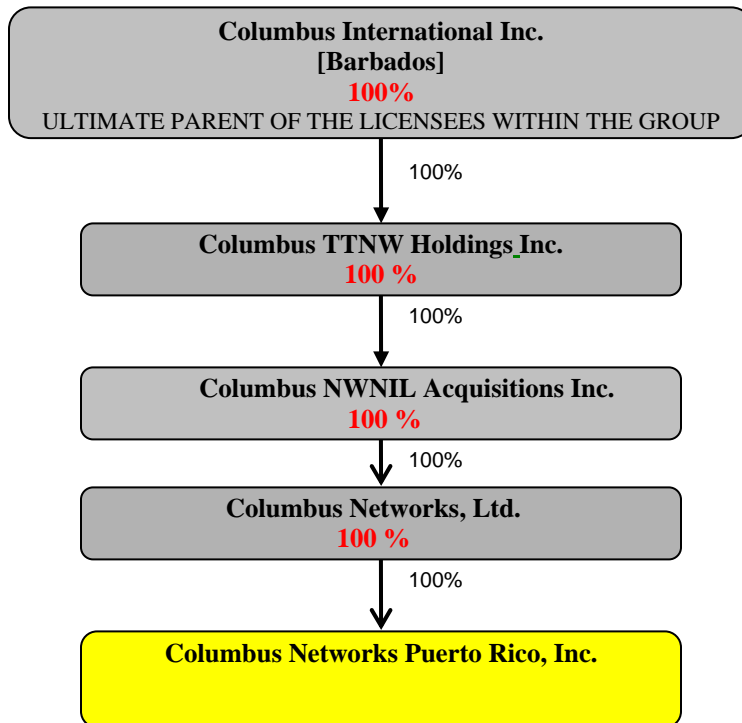

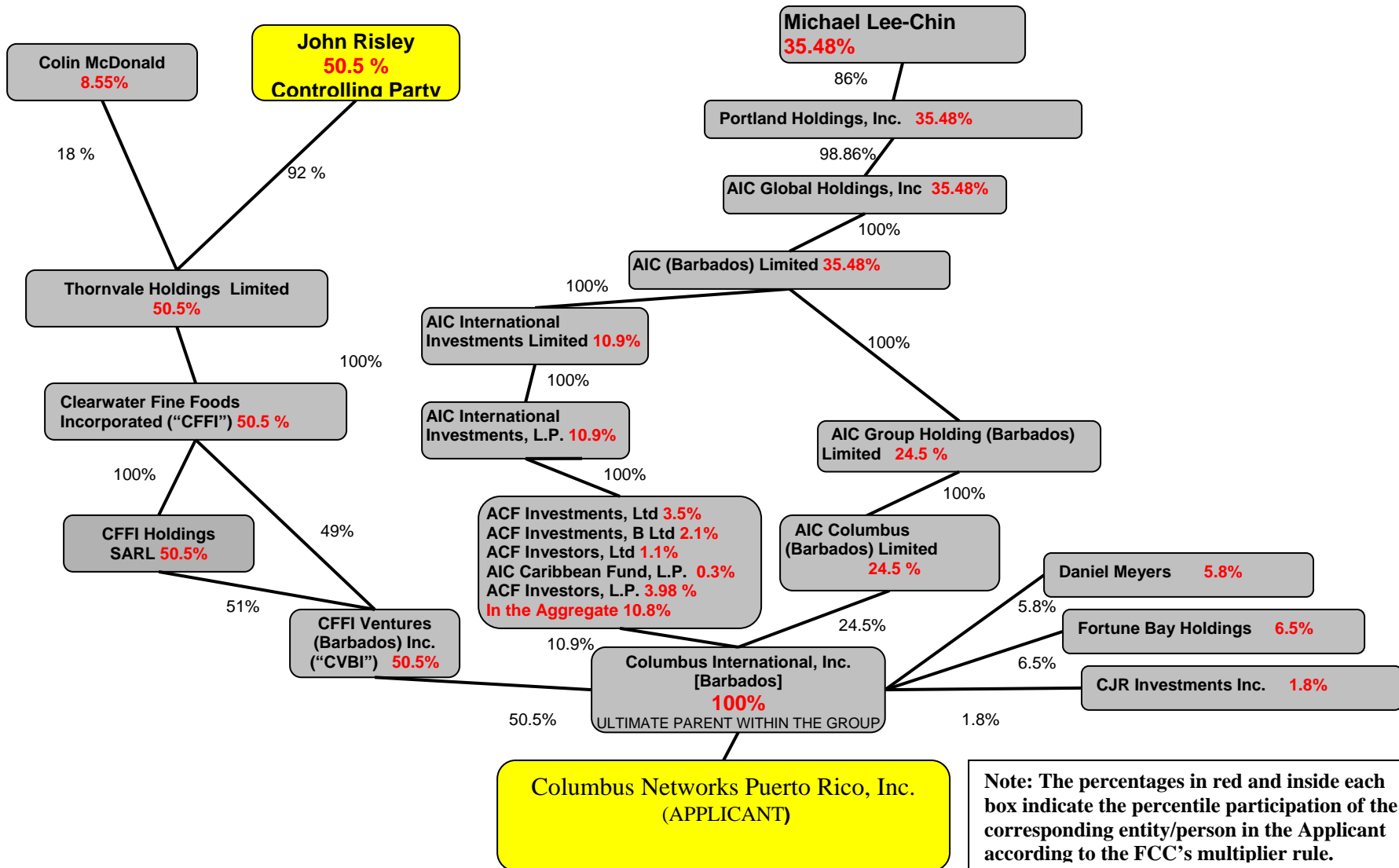

(ultimate parent corporation of the Applicant) currently have international carrier operations in the United States: (1) Trinity Communications Ltd., a subsidiary of Caribbean Crossings controlled by Columbus International Inc., holds an international Section 214 Authorization from the Commission (ITC 214-20030515-00268, pending application for transfer of control, IB Docket No. 09-149); and (2) Columbus Networks Telecommunications Services USA, Inc. (formerly Columbus Networks Services, Inc.), a subsidiary of A. SUR Net, Inc. controlled by Columbus International Inc., holds an international Section 214 Authorization from the Commission (ITC 214-20070220-00077E).

Section 63.18(e)(3) Information. Applicant requests no authorizations other than those under 63.18(e)(1) and Section 63.18(e)(2) of the Commission's rules. Applicant solely requests Section 214 authority to operate as a facilities-based international common carrier pursuant to Section 63.18(e)(1) and to resell the international services of authorized U.S. common carriers pursuant to Section 63.18(e)(2) of the Commission's rules.

Section 63.18(g) Information. Not Applicable. Applicant does not request Section 214 Authority under paragraph (e)(3) of Section 63.18 of the Commission's rules.
