On behalf of Fusion Global Services, LLC (“Fusion Global”), this letter is submitted to notify the Federal Communications Commission (“Commission”) that Fusion Global is surrendering its international Section 214 authorization (File No. ITC-214-20091217-00545) effective immediately. Fusion Global obtained its international 214 authorization on August 31, 2017 pursuant to a *pro forma* assignment from its commonly-owned affiliate, Fidelity Telecom, LLC (File No. ITC-ASG-20170918-00156).

Fusion Global provides interconnected voice over Internet protocol (“VoIP”) services and has not had any international telecommunications service customers within the past thirty days. Consequently, there are no customers to be notified in accordance with Section 63.19(a)(1) of the Commission’s Rules, and no customer notification is attached to this letter.
