PREPA.Net International Wholesale Transport, formerly Inc., Telecomunicaciones Ultramarinas de Puerto Rico, Inc., FRN 0001727304, (hereinafter "PREPA.Net IWT" or "Applicant"), by its attorney and pursuant to Section 214 of the Communications Act of 1934, as amended ("the Act"), 47 U.S.C. 214, hereby requests global authority to (1) operate as a facilities based carrier pursuant to the terms and conditions of Section 63.18 (e) (1) of the Commission's Rules, 47. C.F.R. §63.18 (e) (1), to all foreign points as authorized by the Commission and (2) operates as a resale carrier pursuant to the terms and conditions of Section 63.18 (e) (2) of the Commission's Rules to all foreign points as authorized by the Commission. 47 C.F.R. 63.18 (e) (2). PREPA.Net IWT has no affiliation with any foreign carrier in any of the destination countries for which authority is requested nor is PREPA.Net IWT affiliated with any dominant US carrier whose services PREPA.Net IWT may resell. Thus, pursuant to section 63.10 (a) (1) of the Commission's Rules, 47 C.F.R. 63.10 (a) (1), PREPA.Net IWT should be classified as a non dominant carrier in its provision of international service on all routes. Furthermore, as explained herein, this Application is entitled to streamlined processing under Section 63.12 of the Commission's Rules. 47 C.F.R. 63.12. Prepa.Net IWT is a corporation wholly owned by the Commonwealth of Puerto Rico, exempt from the payment of fees pursuant to Section 1.1114 of the Commission's Rules, 47 C.F.R. 1.1114. As evidenced by the certification provided in Attachment A, PREPA.Net IWT will comply with the terms and conditions contained in Section 63.21, 63.22 and 63.23 of the Commission's Rules. 47 C.F.R. 63.21-23.
- (f) At this time, PREPA.Net IWT does not seek authority to provide service not referenced under paragraph (e) of Section 63.18 of the Commission's Rules. 47 C.F.R. 63.18 (e).
- (g) PREPA.Net IWT will use previously authorized facilities to provide the services requested by the Application. Consequently, PREPA.Net IWT is categorically excluded from environmental assessment pursuant to Section 1.1306 of the Commission's Rules. 47 C.F.R. 1.1306.
- (h) PREPA.Net IWT is owned by PREPA.Net, a non-profit Puerto Rico corporation, a subsidiary of PREPA Holdings LLC, a Delaware limited liability company. PREPA.Net's address is 48 City View Plaza Suite 803 Guaynabo, PR 00968.
- (i) As evidenced by the certification attached hereto as Attachment A, PREPA.Net IWT is not affiliated with a foreign carrier.
- (j) As evidenced by the certification attached hereto as Attachment A, PREPA.Net IWT does not seek to provide international telecommunications services to any destination where: (1) PREPA.Net IWT is a foreign carrier in that country; (2) PREPA.Net IWT controls a foreign carrier in that country; (3) any entity that owns more than a 25% interest in PREPA.Net IWT, or controls PREPA.Net IWT, controls a foreign carrier in



that country; or (4) two or more parties own, in the aggregate, more than 25% of PREPA.Net IWT and are parties to, or the beneficiaries of, a contractual relationship that affects the provision or marketing of international basic telecommunications services in the United States.
