Dear Ms. Dortch:

Hibernia Media, LLC¹ (“Hibernia Media”) by its attorneys, hereby notifies the Federal Communications Commission (“Commission”) that Hibernia Media is surrendering its international Section 214 authorization (referenced above) effective immediately.

By Notice dated April 30, 2015, the Commission was notified that Hibernia Media had completed a *pro forma* merger, with Hibernia Atlantic U.S. LLC, its commonly owned affiliate, with Hibernia Atlantic surviving the merger.² As noted in the pro forma filing, Hibernia Atlantic held an international section 214 authorization prior to the merger and, accordingly, did not need to acquire Hibernia Media’s international section 214 authorization as part of the merger. Consequently, Hibernia Media hereby surrenders its international section 214 authorization.
