Please note that this ownership structure (with the exception of the addition of RDV Corporation) was reviewed by the FCC in connection with other transactions involving Global Tel*Link Corporation (the direct parent of DSI-ITI, LLC) as recent as late 2008 (see File No. ITC-T/C-20080912-00427).
