Section 63.17 Application of Advanced Communications Technology & Services,
Inc. D/B/A CauseBox to Discontinue Services

Advanced Communications Technology & Services, Inc. D/B/A CauseBox ("CauseBox" or "Applicant") hereby seeks authorization pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, to discontinue its provision of interconnected VoIP services. The Applicant intends to discontinue its operations entirely.

Due to a delay in bringing the product to the market, CauseBox decided to curtail all plans moving forward with a VoIP product. This delay was beyond CauseBox's control and resulted in our targeted pricing being obsolete prior to rollout. Only three VoIP phone lines were enrolled as customers with proto-type field units. Our own offices constituted two of the three lines. We only had one customer for one month. That customer was located in the state of Georgia.

CauseBox provides the following information pursuant to Section 67.71 of the Commission's rules:

2. *Date of Planned Service Discontinuance, Reduction or Impairment*

CauseBox proposes to discontinue VoIP services on July 30, 2011.

3. *Points of Geographic Areas of Service Affected*

The interconnected VoIP services that CauseBox proposes to discontinue are offered to a single customer in the state of Georgia. Service includes local, intrastate, interstate and international calling.

4. *Brief Description of Types of Service Affected*

Service includes local, intrastate, interstate and international calling. CauseBox has made arrangements with our wholesale VoIP provider, OneStream Networks, to provide that all services to our customer be transferred without a discontinuation of service. Consequently, our single customer will not experience a disruption in their service upon discontinuance by CauseBox.

5. *Brief Description of Dates and Methods of Notice to All Affected Customers*

Causebox has provided written notice to customer of the planned discontinuance in accordance with the requirements of Section 63.71 (a) of the Commission's Rules by notice dated July 7, 2011. Notice was provided via letter and via letter sent by electronic mail to our affected customer. The customer notice is appended hereto as Exhibit A.

Notice has been sent to the Georgia Public Service Commission, the office of the Georgia Governor and the Department of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit B.

Conclusion

Pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. § 63.71, CauseBox understands that this application will be automatically granted on the 31st day after Public Notice is released, with no Commission notification to the Applicant, unless the Commission has notified the Applicant that the grant will not be automatically effective.

Effective July 30, 2011 CauseBox will no longer be providing voice over IP telecommunications services. We have already taken the necessary steps to transition your service to OneStream Networks, LLC.

There is no anticipated interruption in service, and all services, telephones and customer access websites will remain in place. The complete transition of services will be completed by July 30, 2011 and the number for Customer Support is 800-869-0315, press option 1.

Your comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any liability to acquire reasonable substitute service.
