

**Response to Question 14:**

Wisconsin RSA #7 Limited Partnership (“RSA 7”) is a Wisconsin limited partnership. RSA 7 has not previously received a Section 214 authorization. There are no interlocking directorates with a foreign carrier. Wisconsin RSA #7 General Partner, Inc. will be responsible for managing and operating RSA 7.

No individual or entity controls or holds a 10% or greater interest in the following companies: Amherst Telephone Company, Manawa Telephone Company, Marquette-Adams Telephone Cooperative, Inc., Union Telephone Company, LVT Corporation and Wood County Telephone Company.

Appleton-Oshkosh-Neenan MSA Limited Partnership and Pacific Telecom Cellular, Inc. are wholly-owned subsidiaries of Alltel Communications, LLC, a wholly-owned subsidiary of Alltel Corporation. Alltel Corporation is wholly-owned by Airtouch Cellular. AirTouch Cellular is wholly-owned by Verizon Wireless (VAW) LLC. Verizon Wireless (VAW) LLC is wholly-owned by Cellco Partnership.

Cellco Partnership (“Cellco”) is ultimately owned and controlled by Verizon Communications Inc. (“Verizon”) and Vodafone Group Plc (“Vodafone”). Verizon, a Delaware corporation, owns 55% of Cellco; Vodafone, a company organized under the laws of the United Kingdom, owns 45%. Control of Cellco is vested in a Board of Representatives, which in turn is controlled by Verizon. In sum, Verizon is the majority owner and possesses sole affirmative control of Cellco. The ownership of Verizon and Cellco is a matter of public record. Vodafone’s interest in Cellco, and its qualifications (as a foreign corporation) to hold indirect ownership interests in common carrier licenses have been previously authorized by the FCC under Section 310(b)(4) of the Communications Act.<sup>1</sup> Neither Vodafone nor any of its foreign subsidiaries hold any direct ownership interests in any common carrier licenses. No new foreign ownership issues are raised by this filing. Since the Commission approved the foreign ownership of Cellco Partnership as outlined above in this exhibit, there have been no changes in that foreign ownership.
