A Response to Question 9:

United Communications respectfully requests streamlined processing of this Application pursuant to Section 63.12 of the Commission's Rules. 47 C.F.R. 63.12. This Application qualifies for streamlined processing for the following reasons: (1) United Communications is not affiliated with a foreign carrier on any route for which authority is sought; (2) United Communications is not affiliated with any dominant U.S. carrier whose international switched or private lines services it seeks to resell; and (3) United Communications is not requesting authority to provide switched service over private lines to countries not previously authorized for service by the Commission.

A Response to Question 10:

United Communications does not seek authority to provide switched services over private lines at this time. 47 C.F.R. 63.16

A Response to Question 11:

United Communications is not a foreign carrier and is not affiliated with a foreign carrier. 47 C.F.R. 63.09(e).

United Communications does not seek to provide international telecommunications service to any destination where: (1) United Communications is a foreign carrier in that country; (2) United Communications controls a foreign carrier in that country; (3) any entity that owns more than a 25% interest in United Communications, or controls United Communications, controls a foreign carrier in that country; or (4) two or more parties own, in the aggregate, more than 25% of United Communications and are parties to, or the beneficiaries of, a contractual relationship that affects the provision or marketing of international basic telecommunications services in the United States. 47 C.F.R. 63.18(j)(1-4).
