APPLICATION

4G2World, LLC. (“4G2WORLD or “Applicant”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982), and Section 63.18 of the Federal Communications Commission's (“Commission”) Rules, 47 C.F.R. § 63.18, to provide global or limited facilities-based and resale authority between the United States and international points, except those international points not authorized by the Commission (the “Application”). 4G2WORLD is a U.S. company organized to provide international telecommunications services. 4G2WORLD has no foreign affiliations. 4G2WORLD serves business and residential customers throughout the United States. By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to 4G2WORLD.

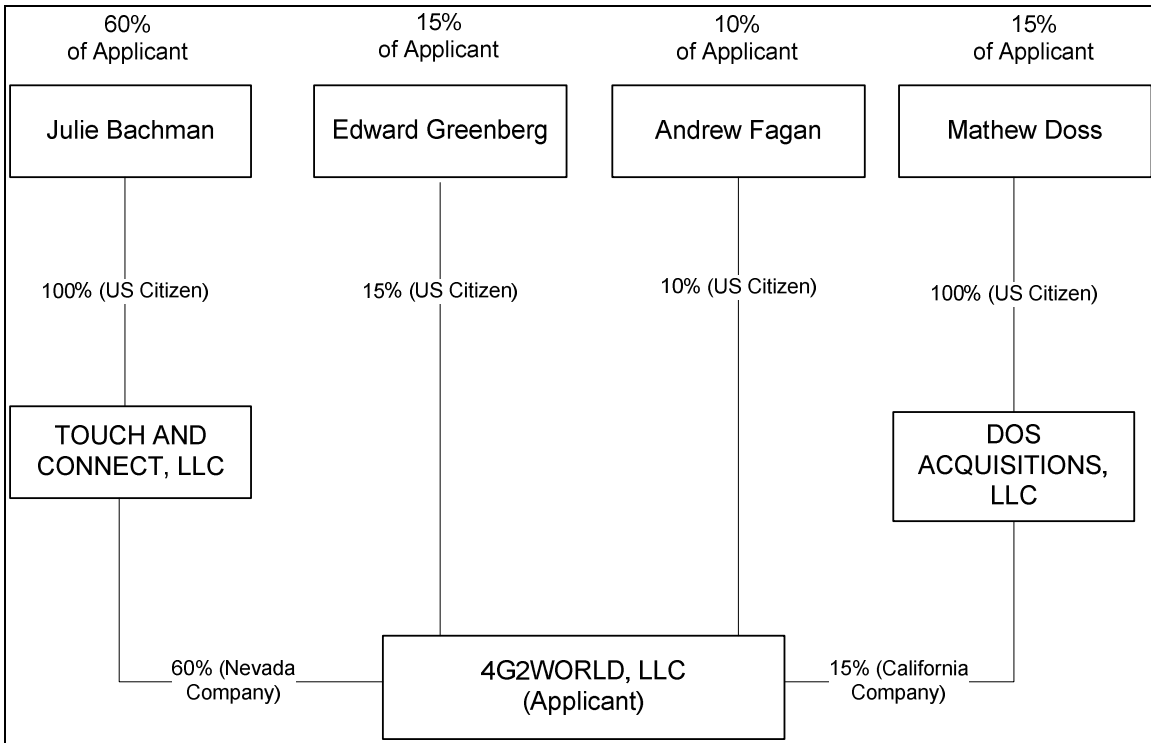

2. It has no affiliation with a dominant U.S. carrier whose international switched or private line services 4G2WORLD seeks authority to resell either directly or indirectly through the resale of another reseller's services;
3. It does not seek authority to provide switched basic services over private lines to a country for which the Commission has not previously authorized the provision of switched services over private lines; and
4. The Commission has not informed 4G2WORLD in writing that this Application is not eligible for streamline processing.

In conclusion, 4G2WORLD certifies that all of the information in this Application is accurate and correct. For these reasons, 4G2WORLD respectfully requests that the Commission grant this Application.
