APPLICATION

4Wire Communications, Inc. ("4Wire Communications, Inc." or "Applicant"), by its attorneys and pursuant to Section 214 of the Communications Act of 1934, as amended ("the Act"), 47 U.S.C. 214, hereby requests authority to operate as a global resale carrier pursuant to the terms and conditions of Section 63.18 (e)(2) of the Commission's Rules to all foreign points as authorized by the Commission. 47 C.F.R. 63.18 (e)(2). 4Wire Communications, Inc. has no affiliation with any foreign carrier in any of the destination countries for which authority is requested nor is 4Wire Communications, Inc. affiliated with any dominant U.S. carrier whose services 4Wire Communications, Inc. may resell. Thus, pursuant to Section 63.10 (a)(1) of the Commission's Rules, 47 C.F.R. 63.10 (a)(1), 4Wire Communications, Inc. should be classified as a non-dominant carrier in its provision of international service on all routes. Furthermore, as explained herein, this Application is entitled to streamlined processing under Section 63.12 of the Commission's Rules. 47 C.F.R. 63.12. According to the FCC's fee schedule, Fee Code CUT, form 159 (payment of applicable fee) is attached hereto.

In support of its request for authority, 4Wire Communications, Inc. submits the following information pursuant to Section 63.18 of the Commission's Rules, 47 C.F.R. 63.18.

(d) 4Wire Communications, Inc. has not previously received Section 214 authority from the Commission.

(e) 4Wire Communications, Inc. is applying for authority to operate as a global resale carrier pursuant to the terms and conditions of Section 63.18 (e)(2) of the Commission's Rules. 47 C.F.R. 63.18 (e)(2). 4Wire Communications, Inc. requests authority to serve all countries permitted under a grant of global authority. As evidenced by the certification provided in Attachment A, 4Wire Communications, Inc. will comply with the terms and conditions contained in Section 63.21, 63.22 and 63.23 of the Commission's Rules. 47 C.F.R. 63.21-23.

(f) At this time, Applicant does not seek authority to provide service not referenced under paragraph (e) of Section 63.18 of the Commission's Rules. 47 C.F.R. 63.18(e).

(g) Not applicable

(h) 4Wire Communications, Inc. is 100 percent owned by Otomi Daniel and Michel Wilton. No entity or individual other than Otomi Daniel and Michel Wilton has 10 percent or more ownership interest in 4Wire Communications, Inc.

(i) As evidenced by the certification attached hereto as Attachment A, 4Wire Communications, Inc. is not affiliated with a foreign carrier.

(j) As evidenced by the certification attached hereto as Attachment A, 4Wire Communications, Inc. does not seek to provide international telecommunications service to any destination where: (1) 4Wire Communications, Inc. is a foreign carrier in that

country; (2) 4Wire Communications, Inc. controls a foreign carrier in that country; (3) any entity that owns more than a 25% interest in 4Wire Communications, Inc., or controls 4Wire Communications, Inc., controls a foreign carrier in that country; or (4) two or more parties own, in the aggregate, more than 25% of 4Wire Communications, Inc. and are parties to, or the beneficiaries of, a contractual relationship that affects the provision or marketing of international basic telecommunications services in the United States.

(k) Not applicable; 4Wire Communications, Inc. is not affiliated or otherwise related to any foreign carrier on any of the routes which 4Wire Communications, Inc. proposed to provide service in this Application.

(l) Not applicable; 4Wire Communications, Inc. is not a foreign carrier and is not affiliated with a foreign carrier on any of the routes it proposes to resell international telecommunications service.

(m) Not applicable; 4Wire Communications, Inc. is not affiliated with any foreign carrier on any of the routes it proposes to provide services.

(n) As evidenced by the certification provided in Attachment A, 4Wire Communications, Inc. has not agreed to accept special concessions directly or indirectly from any foreign carrier with respect to any U.S. international route the foreign carrier possesses sufficient market power on the foreign end of the route to affect competition adversely in the U.S. market and will not enter into such agreements in the future.

(o) As evidenced by the certification provided in Attachment A, no party to this application is subject to a denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988.

(p) 4Wire Communications, Inc. respectfully requests streamlined processing of this Application pursuant to Section 63.12 of the Commission's Rules. 47 C.F.R. 63.12. This Application qualifies for streamlined processing for the following reasons: (1) 4Wire Communications, Inc. is not affiliated with a foreign carrier on any route for which authority is sought; (2) 4Wire Communications, Inc. is not affiliated with any dominant U.S. carrier whose international switched or private lines services it seeks to resell; and (3) 4Wire Communications, Inc. is not requesting authority to provide switched service over private lines to countries not previously authorized for service by the Commission.

Wherefore, 4Wire Communications, Inc. respectfully requests that the Commission grant it authority to provide international telecommunications services on a resale basis pursuant to Section 214 of the Communications Act of 1934, as amended.
