In support of its Application, Telespazio S.p.A. (“Telespazio”) responds below to Sections (d), (e), (g), and (h) of §63.18 of the Commission’s Rules. 47 C.F.R §63.18.

(d) Telespazio has not previously received authority under Section 214 of the Communications Act.

(e) Telespazio seeks Section 214 authority to provide facilities-based and resold domestic and international telecommunications services by utilizing Inmarsat 1-4 satellite located at 52.75 W.L. orbital location, including Broadband Global Area Network (“BGAN”) and Global Satellite Phone Services (“GSPS”) service, in the United States on a common carrier basis.

The BGAN service will support both Internet Protocol packet-switched data and circuit-switched applications. The service will allow data transfer speeds between 384 Kbps to 492 Kbps in the unlink direction, depending on the type of End User Terminal. These higher data transmission rates will allow Telespazio customers to have access to e-mail, local area networks, the Internet, intranet/extranets, videoconferencing services, video-on-demand, and voice communications from almost anywhere in the world. Telespazio expects the Inmarsat BGAN and associated services to be used by a broad range of US users, including enterprise customers, the military, and public safety personnel. This service will enable these and other users to communicate from mobile locations using robust broadband applications at high speeds. The BGAN service is expected to be particularly helpful to the military and public safety officials in the event of a large-scale natural disaster, terrorist attack, or other event that may hamper the stability and availability of traditional terrestrial communications networks. The BGAN service today is available in Europe, Africa, Asia, and the Middle East. The licensing of the use of this service in the United States would enable Telespazio customers to have a truly Global, Mobile Broadband Satellite Service. To summarize, Telespazio BGAN service will offer users, including the United States military and public safety personnel, the ability to access a wide range of broadband applications and services at higher data transmission speeds than are available today from other mobile satellite service offerings.

The GSPS service will involve operation of Inmarsat IsatPhone Pro (“IsatPhone”) devices. IsatPhone is the first handset to be purpose-built for the Inmarsat network, and is the first product in Inmarsat’s family of Global Satellite Phone Services. GSPS is a highly competitive offering in terms of hardware costs, airtime rates, and service Quality. GSPS service is available on a global basis over Inmarsat-4 satellites. IsatPhone will support satellite telephony, including circuit-switched voice, SMS, fax, data, and supplementary services. IsatPhone also supports voicemail, text and email messaging and Bluetooth devices for hands-free use. Location data will also be available to the user to look up or send in a text message.

² It is noted also that the “Agence des participations de l’Etat” (the “French State”), which wholly owns TSA, also holds one “Golden Share” of Thales. This Golden Share (which is included in 2022 shares held by the French State in Thales) entitles the French State to the following rights with respect to Thales: 1) “Any increase in the direct or indirect holding of securities, irrespective of the nature or legal form, beyond a threshold of one-tenth, or a multiple thereof, of the capital or voting rights of the company, but any natural person or legal entity, whether acting alone or in concert, must be approved in advance by the Minister of Economic Affairs..”; 2) “Upon the proposal of the Minister of Defense, a representative of the French State, appointed by decree, sits on the Board of Directors of the company as a non-voting director.”; and “...decisions to dispose of or assign by way of guarantee the assets specified in the annex to this decree may be opposed.” See Thales Registration Document, Filed with the French Financial Markets Authority, April 5, 2011, Section 3.5, page 166.
