On December 30, 2011, the Licensee changed its official corporate name with the **State of Delaware** from Smart Telecard Inc. to SMT Telecom, Inc. due to a name conflict with a pre-existing business in the field of telecommunications that held prior rights to the trade name and branded name. While the licensee did not file with the Commission an Amendment and Notice of Name Change since that time, Licensee however did update its FRN and Form 499 ID to ensure current information with the Commission’s records. The Licensee now desires to cure any confusion on the Commission’s records within the International Bureau created by this oversight.
