Dakota Central Telecommunications Cooperative (“DCTC”) is a cooperative corporation with over 2,000 member-owners, none of which member-owners owns or controls a more than one percent (1%) ownership or voting interest in DCTC. All, or virtually all, of DCTC’s member-owners are United States citizens.

United Telephone Mutual Aid Corporation (“UTMAC”) is a cooperative corporation with over 3,900 member-owners, none of which member-owners owns or controls a more than one percent (1%) ownership or voting interest in UTMAC. All, or virtually all, of UTMAC’s member-owners are United States citizens.

All, or virtually all, of Polar’s member-owners are United States citizens.

Cass County Electric Cooperative (“CCEC”) is a cooperative corporation with over 35,000 member-owners, none of which member-owners owns or controls a more than one percent (1%) ownership or voting interest in CCEC. All, or virtually all, of CCEC’s member-owners are United States citizens.

NOTE: The member-owners of all four of the cooperatives listed above (DCTC, UTMAC, Polar and CCEC) are residents of their respective North Dakota service areas. Whereas all of the more than 46,900 total member-owners of the four cooperatives have been living in North Dakota long

enough to qualify to become cooperative members, IdeaOne cannot be absolutely certain that all such member-owners are U.S. citizens. Rather, it is possible that a very small number of the member-owners of the four cooperatives may be permanent U.S. residents, may be in the process of obtaining U.S. citizenship, or may otherwise yet not be U.S. citizens at this time. None of such possible non-U.S. citizens is known to IdeaOne, and none holds any director, manager, or other position able to influence or participate in the management or operation of IdeaOne.

IdeaOne does not have any interlocking directorates with any foreign carrier.

Response to Question 15: Authorization and Facilities Sought

IdeaOne has not previously received authority under Section 214 of the Communications Act. With the grant of this application, IdeaOne will have international global switched resale authority under Section 214 of the Communications Act.

IdeaOne is not applying for authority to acquire facilities or to provide services not covered by Sections 63.18(e)(1) and Section 63.18(e)(2) of the Commission's Rules. In fact, IdeaOne is seeking only global resale authority under Section 63.18(e)(2) of the Rules. IdeaOne will not construct, acquire or operate its own international facilities, and therefore is not providing a description of facilities or an environmental assessment.

IdeaOne certifies that it will comply with the terms and conditions of Sections 63.21 and 63.23 of the Commission's Rules.
