APPLICATION

Summa Communications, LLC. (“SUMMA COMMUNICATIONS” or “Applicant”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982), and Section 63.18 of the Federal Communications Commission's (“Commission”) Rules, 47 C.F.R. § 63.18, to provide global or limited facilities-based and resale authority between the United States and international points, except those international points not authorized by the Commission (the “Application”). By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. 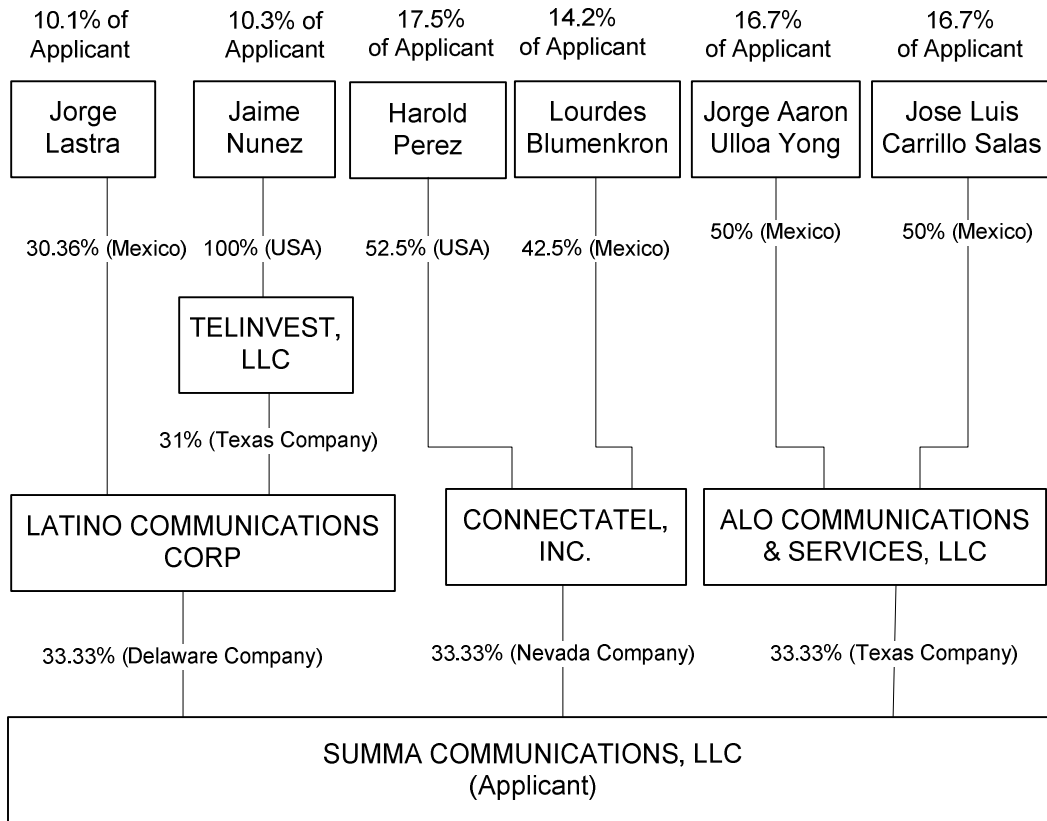


Figure 1. Ownership Diagram
