**SECTION 63.71 APPLICATION OF  
Lan IP Voice, Inc.**

Lan IP Voice, Inc. ("Lan IP Voice"), applies for authority under Section 214(a) of the Communications Act, as amended (the "Act"), 47 U.S.C. §214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue the provision of interstate and international telecommunications services, as outlined below.
