Application of CITIC Telecom International CPC (USA) LLC

Question 9

This Application qualifies for streamlined processing pursuant to Section 63.12(c)(1)(v) of the Commission's Rules. As set forth below, due to its affiliation with foreign carriers in China and Hong Kong, CITIC Telecom International CPC (USA) LLC ("CPC") agrees to be classified as a dominant carrier with respect to the US-China and US-Hong Kong routes, without prejudice to its right to petition for reclassification at a later date.

Questions 11 & 12

CPC provides the following information and certifications as required in Section 63.18(i) through (m) of the Commission's Rules, 47 C.F.R. § 63.18(i)-(m):

- (i) The Applicant certifies that it is not a foreign carrier within the meaning of Section 63.09(d) of the Commission's Rules. The Applicant is affiliated with CITIC Telecom International Limited, a Hong Kong telecommunications provider. CITIC Telecom International Limited, the foreign affiliate, is wholly owned by CITIC Telecom International Holdings Limited. The Applicant is indirectly wholly owned by CITIC Telecom International Holdings Limited. CITIC Telecom International Holdings Limited also indirectly owns CITIC Telecom International CPC Limited, the foreign affiliate. In addition, the Applicant is affiliated with carriers owned or controlled by the Chinese Government, which holds a controlling interest in the Applicant. This includes China Telecommunications Corporation ("China Telecom").
- (j) The Applicant certifies that it seeks to provide international telecommunications services to all global points, except those points on the Commission's Exclusion List.
- (k)-(m) The Applicant certifies that it is affiliated with CITIC Telecom International Limited, a Hong Kong telecommunications provider. CITIC Telecom International Limited, the foreign affiliate, is wholly owned by CITIC Telecom International Holdings Limited. The Applicant is indirectly wholly owned by CITIC Telecom International Holdings Limited also indirectly owns CITIC Telecom International CPC Limited, the foreign affiliate. In addition, the Applicant is affiliated with carriers owned or controlled by the Chinese Government, which holds a controlling interest in the Applicant. This includes China Telecom. Hong Kong has been a WTO Member country since January 1, 1995 and China has been a WTO Member country since December 11, 2001. Applicant agrees to be classified as dominant with respect to the US-China and US-Hong Kong routes, without prejudice to its right to petition for reclassification at a later date. Moreover, the

Applicant agrees to file quarterly traffic reports pursuant to Section 43.61(c) of the Commission's Rules with respect to these routes.

Question 13

As discussed above, Applicant seeks authority to provide service to all global points, except those points on the Commission's Exclusion List.
