
Our records indicate that the international section 214 application (File No. ITC-214-20121009-00253) remains pending at the Commission awaiting completion of review by the Executive Branch. We forwarded the application to the Executive Branch agencies on October 18, 2012. On November 9, 2012, the Commission notified you that the application was removed from streamlined processing pending Executive Branch review.¹

We understand that you have been contacted by the Executive Branch requesting information about the application and you should have provided to them all necessary and requested information. On March 14, 2013, the Commission received an email from the Executive Branch notifying us that there have been no responses to their continued requests for certain information, and that they request the dismissal of the above referenced application.² My staff contacted your office on that date to inquire as to the status of the applicant's responses to the Executive Branch.³ We did not receive a response.

Please inform us no later than August 6, 2013, of the status of the application in the Executive Branch review process and, in particular, confirm that you have provided the information requested by the Executive Branch and the date in which the information was provided.

Failure to respond to this information request will subject your application to dismissal without prejudice under Sections 1.748(a) and 63.51(b) of the Commission's Rules, 47 C.F.R. §§ 1.748(a), 63.18(b).
