We have realized that we used identical FRN numbers for two 214 License applications – which has caused the applications to be flagged in the FCC's system, as follows:

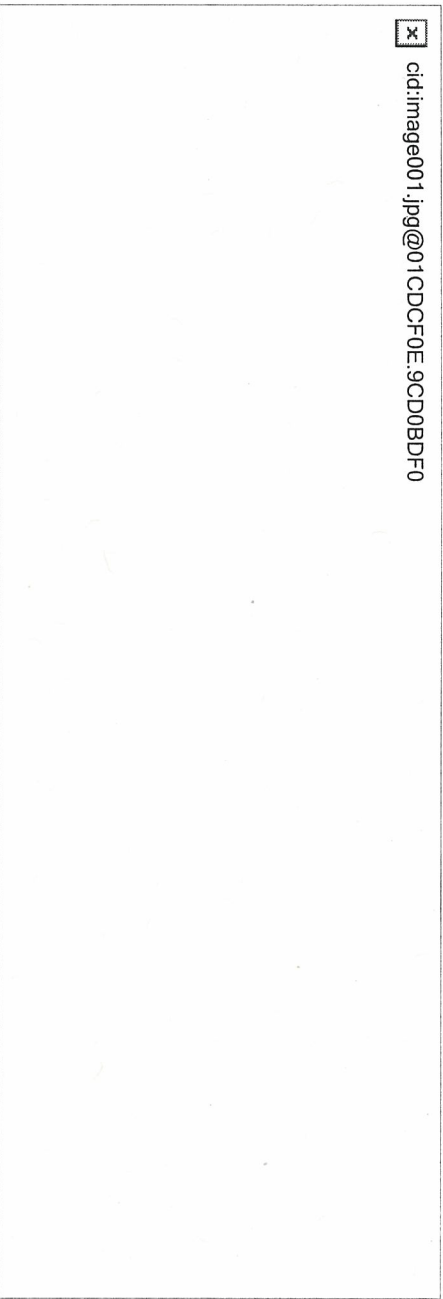
- Clear Call Telecom Inc. (ITC-214-20121101-0027)
- E-N Computers, Inc. (ITC-214-20121101-00279)

The FRN for Clear Call = **0022139208**

The FRN E-N Computer, Inc. *should be:* **0021188503**
