ITC-214-20130110-00008 (e-file)

Glentel Corp.'s application for authority to provide resale services between the United States and permissible international points. Applicant is indirectly 100% owned by a **Canadian** company which is 21% and 16% owned by two **Canadian** citizens, respectively.

ITC-214-20130111-00010 (e-file)

US Matrix Telecommunications, Inc.'s application for authority to provide facilities-based and resale services between the United States and permissible international points. Applicant is indirectly 50% owned by a citizen of **Brazil**.

ITC-214-20130119-00017 (e-file)

Five9, Inc.'s application for authority to provide resale services between the United States and permissible international points. Applicant is 10% or greater owned by a **Canadian** company, Mosaic Capital.

ITC-STA-20130120-00016 (e-file)

Five9, Inc. request a Special Temporary Authority (STA) to provide resale services between the United States and permissible international points. Its underlying application is ITC-214-20130119-00017 (see above).

Applicant has been providing resale of international telecommunications services for several years **without** a section 214 authorization.

Applicant is 10% or greater owned by a **Canadian** company, Mosaic Capital.
