APPLICATION

Procom, Inc. (“PROCOM” or “Applicant”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982), and Section 63.18 of the Federal Communications Commission's (“Commission”) Rules, 47 C.F.R. § 63.18, to provide global facilities-based and resale international authority between the United States and international points, except those international points not authorized by the Commission (the “Application”).
