**APPLICATION FOR AUTHORITY**

**First Technology Development Inc.**, (hereafter also called “Applicant”) hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 214 *et. al.* (1982), and Section 63.18 of the Federal Communication Commission's (hereafter called “Commission”) Rules, 47 C.F.R. Section 63.18, to provide global or limited international facilities-based and resale services between the United States and international points, except those international points not authorized by the Commission and updated from time to time on the Commission’s Exclusion List. First Technology Development Inc. is a U.S. company organized under the laws of the State of Delaware to provide international telecommunications services. First Technology Development Inc. is not affiliated with a foreign dominant carriers holding market control. First Technology Development Inc. is affiliated with a sister company that is a non-dominate telecommunications provider in the Republic of Bangladesh Mir Telecom Ltd. (“Mir Telecom”). Mir Telecom is licensed by the Bangladesh Telecommunication Regulatory Commission to provide International Gateway Services (IGW) and holds certain carrier agreements with U.S. telecommunication Carriers. Mir Telecom is currently one of twenty-nine (29) competitive licensed operators who can route incoming and outgoing international calls to and from the Republic of Bangladesh. Mir Telecom however was one of the first IGW to be issued a license by the

Bangladesh Telecommunication Regulatory Commission, and has maintained itself in good standing for over a decade. The Applicant further states that the Republic of Bangladesh (the country of origin of one of the owners of the Applicant) has been a WTO member since 1995 and has established schedules through the WTO related to the basic telecommunication sector services which should be considered by the Commission. First Technology Development Inc. hereby requests that WTO considerations be applied to that owner and this application by the Commission in any grant of authority.

Finally, First Technology Development Inc. will serve customers throughout the United States thereby increasing options for consumers in the marketplace. By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to First Technology Development Inc.
