Iotum Inc.'s application for authority to provide resale service between the United States and permissible international points. Applicant is located in Toronto, **Canada**. Two **Canadian** companies, each of whom owns 10% or greater of the applicant. Please note that on July 19, 2013, the Executive branch Agencies withdrew their request to defer action, stating that they have no objection to the domestic application for the transfer of control of Global Conference Partner to Iotum Inc. WC Docket No. 12-329 (See the letter from Kristin Taylor, U.S. Department of Justice).

ITC-214-20131017-00275 (e-file)

Telecom Services Network LLC's application for authority to provide facilities based and resale services between the United States and permissible international points. Two citizens of **India**, each of whom owns 50% of the applicant.

ITC-214-20131022-00278 (e-file)

Amaysim USA Inc.'s application for authority to provide facilities based and resale services between the United States and permissible international points. Applicant is 100% owned by an **Australian** company, which is 47% owned by a **German** company and 11% owned by a **Malta** company.
