Section 214 et. al. (1982), and Section 63.18 of the Federal Communication Commission's (hereafter called “Commission”) Rules, 47 C.F.R. Section 63.18, to provide global or limited international facilities-based and resale services between the United States and international points, except those international points not authorized by the Commission and updated from time to time on the Commission’s Exclusion List. Netuno Telecom International Corp. is a U.S. company organized under the laws of the State of Florida to provide international telecommunications services. Netuno Telecom International Corp. is not affiliated with a foreign dominant carriers holding market control.

Finally, Netuno Telecom International Corp. will serve customers throughout the United States thereby increasing options for consumers in the marketplace.
