Cable Andino USA Inc.'s application for authority to provide facilities based and resale services between the United States and permissible international points. Applicant is 100% owned by a **Bahamian** corporation which is 100% owned by Telconet. Telconet, and **Ecuadorian** corporation, is 54% and 46% owned by two citizens of **Ecuador**, respectively.
