
Our records indicate that the international section 214 application filed on behalf of iTalk24 International LLC (File No. ITC-214-20140113-00001) remains pending at the Commission awaiting completion of review by the Executive Branch. We forwarded the application to the Executive Branch agencies on January 23, 2014. On January 31, 2014, the Commission notified you that the application was removed from streamlined processing pending Executive Branch review.¹

We understand that you have been contacted by the Executive Branch in regards to negotiating a Letter of Assurances (LOA). On Tuesday, September 2, 2014 the Executive Branch notified us that they had not received a response to their proposed revisions to the LOA sent on August 8, 2014.²

Please inform us no later than September 18, 2014, of the status of LOA negotiations and, in particular, confirm that contact with the Executive Branch has been made and the date of that contact.

Failure to respond to this information request will subject this application to dismissal without prejudice under Sections 1.748(a) and 63.51(b) of the Commission's Rules, 47 C.F.R. §§ 1.748(a), 63.51(b).

On behalf of iTalk24 International LLC (File No. ITC-214-20140113-00001) ("ITalk24"), this letter responds to the September 4, 2014 letter sent to Mr. Chris Canter, The Compliance Group. iTalk24 has been in communication with the Executive Branch agencies (collectively, "Team Telecom") as they review ITalk24's services to provide their recommendation to the Federal Communications Commission ("FCC") regarding ITalk24's application for an international 214 license.

iTalk24 maintains continued interest in obtaining a 214 license and providing assistance to both Team Telecom and the FCC as the review process moves forward. iTalk24 is reviewing the Letter of Assurances ("LOA") and the additional obligations laid out in the LOA and anticipates responding to Team Telecom shortly.
