
Dear Mr. Khattak:

Our records indicate that your international section 214 application (File No. ITC-214-20140205-00036) remains pending at the Commission awaiting completion of review by the Executive Branch. We forwarded the application to the Executive Branch agencies on March 6, 2014.

We have been informed by the Executive Branch agencies that you have failed to respond to supplemental questions sent to you on May 15, 2014. Completion of Executive Branch review of your application is necessary for final Commission action on it. We attempted to contact your legal counsel on May 28, 2014 to ascertain whether or not Royal Green Communication continued to seek Commission action on the application and to ask about the status of the response to Team Telecom.<sup>1</sup> We received no response to our email inquiry.

Please confirm no later than June 20, 2014 that you have responded to the supplemental Executive Branch questions. Failure to so advise us will subject your application to dismissal without prejudice under Sections 1.748(a) and 63.51(b) of the Commission's Rules, 47 C.F.R. §§ 1.748(a), 63.51(b).
